And everything that we do at Kindred Lutheran is focused on this faith formation process. It is our way of helping one another become the disciple Jesus is calling us to be. 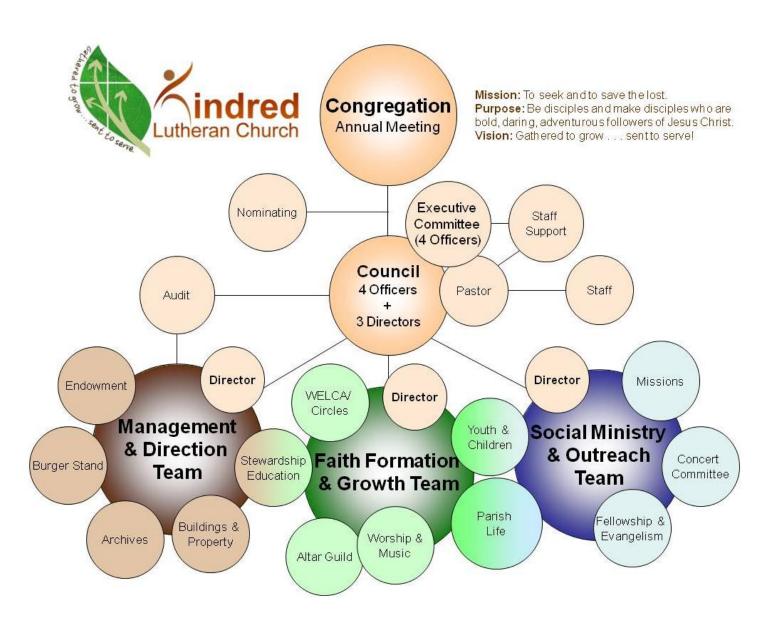

Kindred Lutheran Church February 1, 2015

Unofficial Minutes

The Kindred Lutheran Church Annual Meeting was called to order by President Dona Schock. There were 49 Kindred Lutheran Church members attending the meeting. Pastor Andrew opened with prayer.

SECRETARY'S REPORT

Dona Schock presented the 2014 Annual Meeting minutes to the congregation for review. John Hertsgaard made a motion to approve the February 2, 2014 Annual Meeting minutes. Seconded by Rodney Braaten.

PASTOR'S REPORT

Pastor Andrew Schlecht thanked the congregation for $6 \frac{1}{2}$ years as pastor of Kindred Lutheran Church. He also thanked the Council, Dona Schock for serving 3 years as President, and the staff.

PRESIDENT'S REPORT

Dona Schock thanked the congregation for 3 years as our president.

TREASURER'S REPORT

Treasurer Darren Hoyme presented the reports as printed in the Annual Report. Wes Robertsdahl had a question for Seth about funds for the Food Pantry.

- . Total contributions for 2014 were \$161,813.21
- . Total revenue for 2014 was \$174,799.37
- . Total expenditures for 2014 were \$ 168,484.18

Darren also talked about the house/lot that was purchased East of the church. The purchase price was \$93,500. There is a 25 year loan set up at Kindred State Bank @ 2 ¼ %. Cheryl Rostad moved to approve the treasurer's report as presented. Terry Spelhaug seconded. Motion carried.

The Council was trying to get that done, but late reports came into the office. There was talk of moving the annual meeting back a week or two to be able to distribute the booklets and have time to review them.

PASTOR'S REPORT

Dear Brothers and Sisters in Christ,

As we live faithfully in the present and move forward into God's future, I am excited to announce that Kindred Lutheran Church has been chosen—again! That's right, we have been chosen by Luther Seminary to participate in their Faith Formation Project! Back in 2009 we were chosen to participate in their Biblical Fluency Project and I am excited about the potential to be part of their latest endeavor.

We are one of only a handful of innovating congregations who has been asked to commit to a process of experimental learning designed to clarify the dimensions of intentional faith formation at the center of congregational ministry.

Over the next 18 months, we will work with Luther and the other congregations to form a learning community dedicated to discerning how the Holy Spirit is forming Christian faith in the congregation. This learning is centered on an action reflection team co-chaired by Craig Hertsgaard and myself. I hope that you will find this time to be engaging, inspiring, and spiritually nourishing.

MISSIONS

FEBRUARY

<u>Temple Talks</u>: Laurie Wigtil, Development Director for Lutheran Social Services of ND, gave an informative temple talk during the February 15th worship service about the many programs LSS sponsors in North Dakota. She also spoke to the Sunday School students about how they could help children in North Dakota who weren't as fortunate as them.

<u>Love Offering</u>: A total of \$997 was collected at the February 15th worship service to benefit Jason Allison of Kindred who was diagnosed with ALS.

<u>Lenten Offering</u>: The \$1470 Lenten offering was divided equally between the Lutheran World Relief's "God's Global Barnyard" project and Lutheran Social Services of North Dakota.

<u>Lenten Season Sunday School offerings</u>: \$80 was collected for the LWR's Buck-a-Chick program and \$222.63 was collected to help children in North Dakota through Lutheran Social Services. The classes that raised the most money in each of the two areas were treated to a party by the mission committee. Mission Sunday Worship: April 25th. A video from our Missionary Susan Smith of the Central African Republic was shown. \$100 was collected through a special offering for the creation of new Sunday School materials for Cameroon & CAR Lutheran congregations. Photos of our Sunday School children were mailed with the check and was shared with Sunday school children in the CAR/Cameroon regions. (Update: Missionary Smith reported in January 2016 that the Sunday School materials originally created in English, are now being translated into Sango and French – the languages of the CAR and Cameroon – and new teachers are being educated on the materials to better teach the children⁽¹⁾).

BURGER STAND

For nearly ten years the KLC Burger Stand has been one of the main food providers at the Kindred Days celebration. Along with the best burgers around, this year we added Granny B's baked beans.
