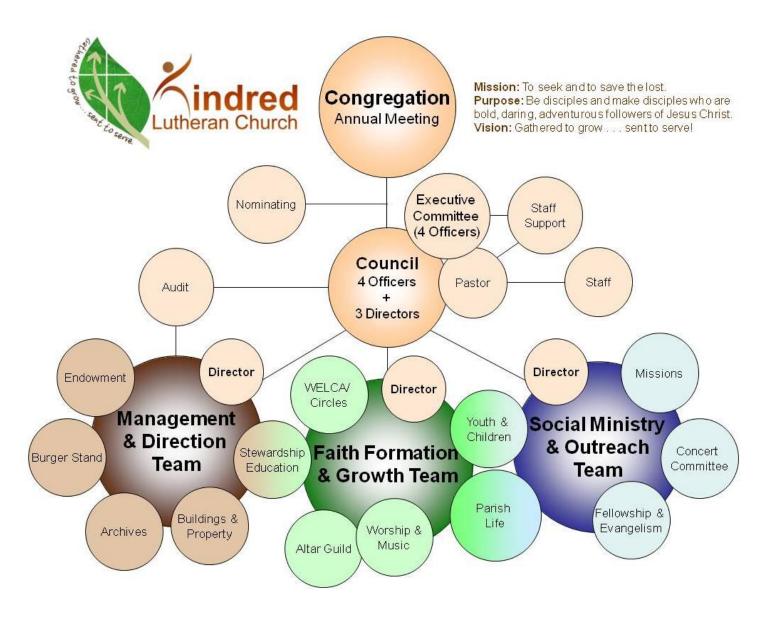

2014 ANNUAL MEETING MINUTES

Kindred Lutheran Church February 2, 2014 Unofficial Minutes

The Kindred Lutheran Church Annual Meeting was called to order by President Dona Schock. There were 41 Kindred Lutheran Church members attending the meeting. Pastor Andrew opened with prayer.

SECRETARY'S REPORT

Dona Schock presented the 2013 Annual Meeting minutes to the congregation for review. John Hertsgaard made a motion to approve the February 3, 2013 Annual Meeting minutes. Seconded by Barb Rude. Motion carried.

PASTOR'S REPORT

Pastor Andrew Schlecht thanked the congregation for an amazing year and reflected on his 5+ years as pastor of KLC. He also thanked the staff and church council.

PRESIDENT'S REPORT

Dona Schock referred the congregation to her printed report in the Annual Report. She also noted that both Terry Spelhaug and Brandon Kub had served three years on church council and would be ending their term.

TREASURER'S REPORT

Treasurer Brandon Kub was absent, therefore Dona Schock presented the reports as printed in the Annual Report. The Burger Stand earnings were put into a special fund. Wes Robertsdahl noted that the \$1,200 contribution from the senior center should show up as revenue and was not noted on the report.

- Total contributions for 2013 were \$128,482.15
- Total Revenue for 2013 was \$134,670.20
- Total Expenditures for 2013 were \$147,324.62

Jean Hertsgaard moved to approve the treasurer's report as presented. Scott Milbrandt seconded. Motion carried.

ACCEPTANCE OF PRINTED REPORTS

The congregation reviewed the printed reports and asked questions. Velora Robertsdahl noted that the Parish Life report was accidentally omitted from the Annual Report. After addressing and discussing the congregation's questions, a motion was made by Kevin Kvamme to approve all printed reports in the Annual Report. Rodney Braaten seconded. Motion carried.

Terry Spelhaug moved to approve the slate of the nominating committee. Seconded by Darren Hoyme. Motion carried.

PRESENTATION OF THE 2014 BUDGET

The 2014 budget was discussed. Dona Schock noted the increase in Pastor Andrew's medical expense. She also noted that the office will be getting a new copy machine. The current office copy machine will replace the one in the Sunday school room. Cheryl Rostad asked for clarification regarding how and when the choir director gets paid, and also noted that the organ is in need of tuning.

The 2014 budget was presented stating a total budget of \$153,850.00. Council approved a 3% raise in Pastor Andrew Schlecht's salary. Jean Hertsgaard made a motion to approve the 2014 budget as presented. Adam Spelhaug seconded. Motion carried.

OLD BUSINESS

None.

NEW BUSINESS

The option of electronic giving is available to KLC members. This can also be done through the Kindred Lutheran Church website. Members also have the option to designate their giving electronically for special items and holidays.

Cheryl Rostad suggested that the annual reports be distributed a week prior to the annual meeting so people have time to thoroughly read them before the meeting.

The congregation also suggested that the line-items in the budget be cleaned-up/consolidated so that money is easier to track.

John Hertsgaard recognized and gave thanks to outgoing council members as well as the Schlecht family.

Kevin Kvamme moved to adjourn the meeting, seconded by Barb Rude. Motion carried.

As I leave the council after 3 years as your president, I cannot tell you how proud I am of all of you. It's been a great time and I look forward to seeing what will happen in the years to come.

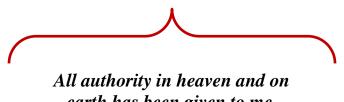

PASTOR'S REPORT

Dear Brothers and Sisters in Christ,

"Be Disciples and make Disciples of Jesus Christ."

Jesus commands us in Matthew 28:18-20:



earth has been given to me. Therefore go and make disciples of all nations, baptizing them in the name of the Father and of the Son and of the Holy Spirit, and teaching them to obey everything I have commanded you. And surely I am with you always, to the very end of the age.

Simple command.

Go. Make disciples. Baptize. Teach. Obey.

(Note, Jesus doesn't tell us to make Christians.) He didn't ask for our opinion and it wasn't a suggestion. Jesus is not interested in excuses. To *be* a disciple also means to *make* disciples.

Pastor David Platt tells a story about visiting Africa. As he is preaching, he notices that no one is looking at him. Instead, they are busy taking copious notes. He asks, "Why are you writing everything down?"

Their response startled him, "We are writing down what you are saying so we can teach it to other people." They were not listening just for the sake of listening. They were listening in order to make disciples of Jesus Christ in fulfillment of his command. Of course, in most worship services in the good old USA, people sit passively, as if they are in an audience and it is the pastor's job to entertain them. Hopefully, some people are listening intently to see how it applies to their lives, but very few are actually listening in order to make disciples.

Pastor David Platt observes, "We are, by nature, receivers. Even if we have a desire to learn God's Word, we still listen from a default self-centered mind-set that is always asking, 'What can I get out of this?' ... What if we changed the question whenever we gathered to learn God's Word? What if we began to think, 'How can I listen to his Word so that I am equipped to teach this Word to others?'"

In other words, how do we: "Be Disciples and make Disciples of Jesus Christ?

Wow! God's Word would not be restricted to the four walls of our church building or just to the people who attend worship on Sunday mornings. Instead, God's Word will multiply. God's Word will makes disciples.

So part of our emphasis during 2015 is to explore what it means to make disciples. As you have discovered since Christmas, this means encouraging one another to take notes during sermons, all the while asking yourself, **"How can I** *listen to Jesus' Word so that I am equipped to teach his Word to others?"*

Why? Because Jesus' command to make disciples means that making disciples is our responsibility all of us, individually and collectively. It is not just my responsibility as the pastor, Kitty's responsibility in confirmation, Craig's responsibility in adult Bible study or the teachers' responsibility in Sunday school. It is your responsibility, too. What a great privilege and a blessing! Thankfully, we do not make disciples alone. Not only do we have each other, but Jesus sends the Holy Spirit to empower and guide us.

To be clear, note taking is not a measure of our faith in Jesus or a way to achieve salvation. It is simply a tool to help us rethink our responsibility as disciples who make disciples.

Will it be difficult? Will it be challenging? Will it be uncomfortable? Yes. But then again, Jesus never promised that being a disciple would be easy. On the contrary, Jesus tells us to deny ourselves, take up our cross and follow him (Luke 9:23-26). He warns us to count the cost and give up everything (Luke 14:25-33). Unless a grain of wheat dies, it remains only a single seed (John 12:24-26). Apart from Jesus, we can do nothing (John 15:5).

Following Jesus is expensive. But the rewards are beyond measure. I am reminded of the hymn, "Go, Make Disciples" that we sang during worship:

> Go, make disciples, baptizing them, teaching them. Go, make disciples, for I am with you till the end of time. Go, be the salt of the earth. Go, be the light of the world. Go, be a city on a hill, so all can see that you're serving me. Go, make disciples.

It is our goal to keep ticket prices at \$20, keeping it affordable for everybody even though other venues are charging up to \$45 per ticket for the same bands. We are only able to do this by getting sponsorship money from local businesses and music lovers in general. We ended the first show with \$500 cash on hand plus another \$400 in future revenue for the next show. We hope to double our sponsors to 100 for 2015. We would also like to thank Eleanor Braaten for buying the hotel rooms for the Good Lovelies, as well as everybody who gave cash for meals and incidentals. We greatly appreciate the projector and screen which we used for promotion and during the show, thank you to all the people who gave money for this equipment especially the family of Jim Roe who gave the first gift of money as a memorial for their husband and father.

God has given the wonderful gift of music to many people, but the bands we are booking have received that gift a hundred fold. Come out and enjoy what God has given!

After an intense spring of prayer, study and role playing exercises, the Stephen Ministry team (SMT) completed the required 50 hours of training. Six wonderful, giving people were commissioned as Stephen Ministers on May 18, each fully trained to provide one-to-one, Christ-centered care to people going through tough times. Please continue to pray for Joan Ottis, Cheryl Rostad, Dona Schock, Scott Gietzen, Vallorie Schlecht and Michelle Gietzen as they serve others at KLC and in our community.

After a summer break, the team started meeting again to practice group supervision, the process used to monitor and support each other as members provide care for others. Some Stephen Ministers have been connected with care receivers this fall and winter, and the remainder will be assigned this month.

Each month, the SMT meets twice for two purposes—supervision and continued education. This will be standard practice from now on. The Leadership team is considering training additional Stephen Ministers next fall and building the leadership team as time goes on.

Stephen Ministry is a church-wide program and congregational members are a vital part of the process. Do you have a friend, neighbor, coworker, or relative who is going through a difficult time? Here's a great way you can help them—tell them about our Stephen Ministry! Stephen Ministers are members of *KLC* who have received special training to provide high-quality, confidential, one-to-one, Christian care to people who are grieving the loss of a loved one, coping with a cancer diagnosis, going through a divorce or separation, battling a chronic illness (or caring for a spouse or parent who is chronically ill), experiencing a great deal of stress, facing the loss of a job—or encountering any of countless other life challenges.

Stephen Ministers meet weekly with their care receivers to listen, care, encourage, and provide emotional and spiritual support. (Males are matched with males, and females are matched with females.) The caring relationship lasts for as long as the person needs care. It's free, and it's a powerful way you can help a hurting friend.
