And everything that we do at Kindred Lutheran is focused on this faith formation process. It is our way of helping one another become the disciple Jesus is calling us to be. 

2013 ANNUAL MEETING MINUTES

Kindred Lutheran Church February 3, 2013

Unofficial Minutes

The Kindred Lutheran Church Annual Meeting was called to order by President Dona Schock. There were 33 Kindred Lutheran Church members attending the meeting. Pastor Andrew Schlecht opened the meeting with prayer.

SECRETARY'S REPORT

Dona Schock presented the 2012 Annual Meeting minutes to the congregation for review. Scott Milbrandt made a motion to approve the February 5, 2012 Annual Meeting minutes. Seconded by Christine Ilvedson. Motion carried.

PASTOR'S REPORT

Pastor Andrew Schlecht thanked the 125th Anniversary Committee. He highlighted the success of the Faith In Action Sunday. Pastor Andrew also noted that Kindred Lutheran Church gave away 10% of their offering to various causes, meeting a goal of his for KLC. He thanked the council for their support, and also gave special thanks to the KLC staff and volunteers.

PRESIDENT'S REPORT

President Dona Schock referred the congregation to her printed report in the Annual Report about compassion.

TREASURER'S REPORT

Treasurer Brandon Kub noted that total contributions for 2012 were \$144,585.00. The balance at the end of 2012 was \$5,466.79.

Brandon presented the General Fund Report. Lavonne Nokleberg moved to approve the report as presented. Seconded by Cheryl Rostad. Motion carried.

Brandon presented the Total Liabilities and Net Assets Report. Total Net Assets and Liabilities listed on the balance sheet were \$428,360.14. Leah Lundquist moved to approve the report as presented. Rodney Braaten seconded. Motion carried.

Brandon presented the Expense Statement. Rodney Braaten moved to approve the report as presented. Leah Lundquist seconded. Motion carried.

ACCEPTANCE OF PRINTED REPORTS

The congregation reviewed the printed reports and asked questions:

- Vallorie Schlecht inquired about insured FDIC amounts and asked if somebody is watching this.
- Irene Roe asked why the giving envelopes no longer have "missions" as a designation option on them.
- Vallorie Schlecht noted that the Altar Guild is in need of 2 volunteers to serve on the committee.
- Barb Rude asked how much is taken out of the general budget for benevolence funds.
- Cheryl Rostad asked for clarification of the organist and choir director pay.

After addressing the congregation's questions, a motion was made by Kevin Kvamme to approve all printed reports in the Annual Report. Deb Perhus seconded. Motion carried.

NOMINATING COMMITTEE REPORT

Christine Ilvedson presented the Nominating Committee report. Kari Johnson will be taking Jasmine MacFarlane's secretary position on church council. She noted that there are still two open positions on church council, and that two representatives are also needed to attend the Synod Assembly. Vallorie Schlecht and Cheryl Rostad nominated themselves to attend the Synod Assembly. Christine noted that the Nominating Committee for 2013 will be: Kitty Blilie, Leah Lundquist and Jasmine MacFarlane. Irene Roe moved to approve the entire slate of the nominating committee. Seconded by Altha Johnson. Motion carried.

OLD BUSINESS

President Dona Schock thanked Rodney Braaten, Steve Halland and Rich Schock for installing the screen and projector system for the sanctuary. She also thanked Rodney Braaten and Kelly Perhus for their snow removal services, and Kitty Blilie for her service on Church Council.

NEW BUSINESS

NOMINATIONS

The floor was opened for nominations to fill open Church Council positions. There were no nominations.

PRAYER GARDEN

Rich Schock gave an update on the progress of the Prayer Garden project. Currently there are three contractors bidding on the project. The committee is hoping to break ground in May.

PRESENTATION OF THE 2013 BUDGET

The 2013 budget was presented stating a total budget of \$149,687.00. Treasurer Brandon Kub explained that council voted to increase Pastor Andrew Schlecht's salary by 6%. \$3,600 was also added in to the budget for the church custodian salary. Brandon also noted that the expense line item of Maintenance Supplies was combined with the line item of Church Repairs/Maintenance Expense. Rodney Braaten made a motion to approve the 2013 budget as presented. Kevin Kvamme seconded. Motion carried.

Dona Schock moved to adjourn the meeting, seconded by Altha Johnson. Motion carried.

SPECIAL CONGREGATIONAL MEETING #1

July 14, 2013 10:00 AM.

President Dona Schock and Rich Schock presented the options of the parking lot project to the congregation in the form of a power point presentation on the overhead screen. An informational meeting was also held on Wednesday, July 10, 2013 at 7:30 PM and was headed by Rich Schock, Kevin Kvamme, and Brandon Kub.

The overall discussion of the congregation was in favor of replacing the parking lot. Many discussions occurred regarding the logistics of how to pay for the project. The floor was opened for questions and comments.

Motion was made by Todd Toppen for the following:

We make the following motion:

- 1. Authorize the council to refine the bids to obtain a clear line between the parking lot project and the prayer garden project for possible 2014 work.
- 2. Begin a fund raising goal of \$50,000.00 for the parking lot and use non-matching endowment funds for the remainder of true costs. This project should include all drainage costs on the east and west side of the church and be completed first or in conjunction with the prayer garden.
- 3. Continue fundraising for the prayer garden to reach 100% of true costs before starting.
- 4. Driveway loop project is put on hold until resolution of possible neighbor lot purchase.
- 5. At or near completion of the fundraisings efforts, the plan should be submitted to the congregation for final approval.

Discussion ensued. Motion was seconded by Mark Kuhn. Voting followed with Deb Perhus and David Johnson counting the votes.

Voting results: YES: 32, NO: 22 with 56 members present. Motion carried.

Meeting adjourned by Dona Schock, President.

Dear Brothers and Sisters in Christ,

And he invites the likes of you and me right here in Kindred, North Dakota, to be a part of his mission along with billions of Christians throughout the world! Wow!

I am so blessed to be a part of this faith community, to be partnered with you as we seek together to answer these challenging questions while we faithfully serve our Lord and Savior. Because in the end it is not about us—it is all about Jesus!

Where have I seen God's presence over the past year? God is clearly at work here at Kindred Lutheran Church—in your lives and in our community. Here are just a few of the places I see Him at work:

Be a Joy Maker!

The youth and adults spent the afternoon making pillow cases for women and children who are staying at the YWCA shelter in Fargo. Each pillow case included a Bible verse, Psalms 4:8 "In peace I will lie down and sleep, for you alone, Lord, make me dwell in safety." In return for their volunteer time Hasbro and GenerationOn.org gave us 100 toys to donate to children in need!

Passover Seder Dinner

Jews for Jesus led us in a celebration of the Passover Seder dinner as we made the connection between God's saving work in Exodus and his saving work through Jesus.

Operation Christmas Child

The youth and adults were able to deliver 55 boxes to children throughout the world.

Feeding the Homeless

Beginning last August, we have been sending a team of 5 to 6 adults and youth to Churches United for the Homeless in Moorhead to prepare and serve a meal for 100 or more adults and youth on the third Friday of every month. We now have 25 volunteers willing to help feed the homeless!

Donuts and Dwelling in the Word

On Sunday mornings, a faithful group of adults gather together to dwell in God's Word and be transformed by the power of the Holy Spirit!

Holiday Food Baskets

Partnering with churches throughout the area, we helped bless 76 families during Thanksgiving, Christmas and Easter.

Stephen Ministry

As a Stephen Ministry congregation, Kindred Lutheran Church equips and empowers lay caregivers—called Stephen Ministers—to provide high-quality, confidential, Christ-centered care to people who are going through tough times. Currently 6 members of KLC are being trained for this new ministry.

Youth and Children

They are amazing! Their energy, curiosity, openness, love and faith are contagious! Jesus tells us, "Let the little children come to me, and do not hinder them, for the kingdom of God belongs to such as these. Truly I tell you, anyone who will not receive the kingdom of God like a little child will never enter it" (Luke 18:16-17).

Worship

The heart of worship is God and what God does—not us, our faith, or our experiences. God freely gives us the gifts of his presence, forgiveness and salvation. God speaks to us through the written Word of Scripture, the proclaimed Word in the sermon and hymns and songs, and the visible Words of communion and baptism. We are blessed with an amazing music team, including musicians, directors and singers. And who can forget the children's songs and their bell choir!

Prayer Walk and Chili Feed

As we walk, run and ride, we pray for commuters, truck drivers, bus drivers, and train engineers . . . we pray for the farmers, the workers in the fields and for a bountiful harvest . . . we pray for the new residents in our community and for people of all faiths . . . we pray for reconciliation, forgiveness and peace . . . we pray for our families, students, teachers, and staff at our schools. Amen!

WORSHIP COMMITTEE

The Worship Committee is excited that our church hired a person to clean in 2013. So now when people choose a month on the sign-up board in the narthex, it's only for <u>ushering and fellowship</u>. Those who do not sign up are assigned to a month that does not have enough people to cover these areas (but remember that we can negotiate months or Sundays if a wrong month was chosen).

Here is a basic description of ushering and fellowship:

If you are **ushering**, arrive about 15 minutes early to hand out bulletins and greet people with your friendly smile, light the two candles on the altar, count people (record it on the paper on the usher's table), pass offering plates, help with communion (as needed), and tidy up the pews after the service.

If you are helping with **fellowship**, bring some goodies to share (this can be absolutely anything), have things ready to go when church is over (your goodies, coffee, water, juice, fellowship offering basket) and serve refills of coffee, etc. as needed. Use the dishwasher for the rinsed-off dishes (see instructions posted above it). Then count the money, put it in an envelope with the date and put it in the church office.

For ushering and fellowship, we try to have at least four people to help so you aren't alone. It's a great way to get to know one another and have some fun at the same time!

Our committee also decorates the church for holidays, etc., and we are responsible for changing the banners to coordinate with the church year. There are many other things that we do, and Pastor Andrew guides us with his detail-oriented creativity!

MISSIONS

The responsibilities the committee focused on in 2013 were:

- 1. Develop a wider sense of the church's mission to the world, including: missionary sponsorship, supporting our companion synod, the Central African Republic, and supporting regional and local charities/individuals as designated by the committee.
 - a. <u>Missionary sponsorship</u>: The budget passed at the 2011 annual meeting included sponsorship of Missionary Jacalyn Rose Griffin of the Central African Republic (CAR), in the amount of \$1000/year for three years. We tried several times in 2013 to contact Jacalyn to get an update on her work but were unsuccessful. We learned from the ELCA Global Missions that she was working out of Cameroon, West Africa. We heard from her once in 2013 despite several attempts again to contact her. Our committee feels it is very important for Kindred Lutheran to have a relationship with our missionary, so with the ELCA's blessing we changed our sponsorship to support **Missionary Susan Smith**, an advisor to the education programs. She has a blog which you can access at http://susan-car.blogspot.com/. We will keep the congregation posted with her work. We look forward to having a great relationship with her!
 - b. <u>Central African Republic (CAR)</u>: The CAR has experienced horrific civil unrest in 2013 as a rebel group had occupied the country. Conditions were unsafe for residents and missionaries alike. Therefore, it was difficult for our committee to know how to support them when we weren't sure if the money would get into the right hands. Then, in November, the EaND Synod started a campaign "Faith Aid in the CAR" where \$5,000 will be matched if donated by November 30th. The committee recommended to the council that \$1500 of our "Other Benevolence" be given. Approved.
- 2. Coordinate the special offerings throughout the year
 - a. The Love Offering collected on February 24th was given to the Kindred chapter of Fellowship of Christian Athletes (FCA) in the amount of \$415.00.
 - b. <u>Lenten worship offering</u> was designated to go to "God's Global Barnyard". \$1185 was collected.
 - c. <u>Lenten soup & sandwich supper offering</u> was designated to go to the KLC Emergency Fund. \$259.75 was collected.
 - d. <u>Synod Endowment Fund</u>. The Eastern North Dakota Synod set up this fund to help pay for seminary expenses to new pastors coming to serve congregations in North Dakota. New pastors benefitting from this fund said it played a large role in choosing to serve in our state. Total amount collected was: \$65.00.
 - e. Thank Offering: was designed to go to the Great Plains Food Bank. \$30.00 was collected.
- 3. Identify and lead serving opportunities in coordination with other committees
 - a. The ELCA celebrated its 25th anniversary by inviting all congregations to participate in "God's Work. Our Hands Sunday" this fall by holding an event(s) on a Sunday that would help our neighbors. Our event was held October 13th.
 - i. Global: The mission committee worked with the Sunday School children during the Sunday School in assembling 50 school kits for Lutheran World Relief. The kits were blessed during worship. The mission committee also held a fair trade coffee taste testing the week prior and served fair trade coffee following worship on the 13th. The fellowship committee will serve fair trade coffee beginning in January.
 - ii. Regionally: Volunteers signed up to sort, label and package food at the Great Plains Food Bank (this was held October 10th).
 - iii. <u>Local</u>: Volunteers signed up to serve food once/month at Churches United for the Homeless in Moorhead.
- 4. Participate and/or sponsor programs to inform and educate members and the community regarding social needs or issues
 - a. <u>Malaria Campaign</u> was launched in April and coordinated by Ruth Bachmeier. An informational display was set up in the narthex, 150 "mosquitoes" were hung throughout the church building representing the committee's goal of raising \$1,500, and temple talks were given every Sunday in April. The campaign concluded with a special "Malaria Sunday" worship service. A total of \$1,655.00 was collected. Thanks KLC!! .
 - b. Soap collection. 80 new bars of soap was collected in May and sent to Lutheran World Relief.
 - c. <u>Lutheran World Relief Handcraft Fair</u> was held on November 3rd during the Men's Ham Dinner. Beautiful handcraft items made by artisans from third world countries were sold in the narthex. A total of \$1,057 was sold and will directly benefit the families who made these items as well as their countries. The committee made a net profit of \$119.85 (including shipping for special orders) which will be used for upcoming mission expenses.
 - The Mission Committee recommended sending our 2013 budgeted Other Benevolence dollars to the following recipients. Council approved.
 - a. Central African Republic: \$1,500
 - b. Peg Tommeraus Fund: \$500

- c. Wickenheiser Children Fund: \$500
- d. YWCA Shelter: \$500
- 6. As of December 31, 2013, the Flaa Fund balance was \$17,756.44. The following disbursements were made in 2013:
 - a. Peg Tommeraus Fund: \$500
 - b. Wickenheiser Children Fund: \$500
 - c. YWCA Shelter: \$500
 - d. The committee will also send \$1,000 to the Kindred School to start a special discretionary fund. This fund will be used for children who need basic items (ie. Outerwear, shoes/boots, milk money, activity passes, etc.) We will get a report at the end of 2014 from the school as to how the money was used. We also left it with the school that if more money was needed, to contact us.
 - e. The Kindred School is also working on an Anti-Bullying Program. Start up costs will be minor. Flaa Fund money will also be used for these expenses

Fair Trade Coffee offers a "fair, just, and equitable marketplace for small-scale farmers around the world" (cuts out the middle man so these poor farmers can earn a decent living). We are serving this quality coffee in our church kitchen and also involved in a great ministry.

The committee will be revising the current serving groups and chairpersons. The KLC membership is currently divided by their last name alphabetically into three working groups (Matthew, Mark, and Luke), and the members serve two months at a time for potlucks and funeral luncheons. Potlucks are held the last Sunday of the month, unless otherwise indicated. The list, when revised, will be posted on the bulletin board in Fellowship Hall and also on the website.

The committee also served and coordinated servers for the Lenten suppers, Confirmation dinner, and Christmas Program dinner.
