Make Disciples. Baptize. Teach. Obey. But being a disciple of Jesus is not a self-help project where we make ourselves better or more worthy or more like Christ. We don't earn salvation. Rather, the Holy Spirit transforms us so we become more like Jesus for others. We grow in grace – grow in seeing how totally dependent we are upon God's graciousness to us.

Vision

Following Jesus is a journey, a lifelong process of faith formation that we describe simply as: **Gathered to Grow...Sent to Serve!** This is our vision. And everything that we do at Kindred Lutheran is focused on this faith formation process. It is our way of helping one another become the disciple Jesus is calling us to be. Discipleship is what **we** do. Faith formation is what **God** does.

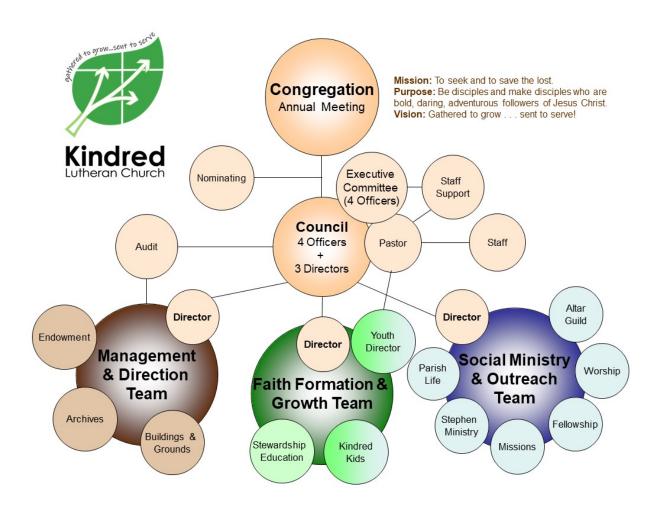

PRESIDENT'S REPORT

It is hard to believe that it has been five years since I first joined the council of Kindred Lutheran Church. I had the privilege to serve on this council with people who have become my friends and left a thumbprint on my heart. I also had the privilege to serve for an amazing congregation who put their faith and trust in this council through trials and tribulations, particularly the past few years.

As we continued to adjust, more change came about when our administrative assistant followed her faith that brought her on a different path. With Bekki's resignation, we found ourselves facing yet another trial. Fortunately, our prayers were once again answered when Leah Lundquist joined the staff of KLC in the fall of 2022. She has been a wonderful addition, a ray of sunshine, and we are blessed once again.

As we start 2023, let us have faith in the trials that we may face personally, professionally, or spiritually. Pray, be patient, and persevere.

Thank you to all of those that served on this council with me at one time or another. You have all been a rock to me in more ways than I could express. Thank you to the staff, all the Committee Chairs and Committee Members. Your love for Christ, one another, and this church is evident in all that you do. And thank you to all of you for your faith and support of myself and this council. KLC truly is the best.

PASTOR'S REPORT

Dear Siblings in Christ,

Last February, you all gathered together to vote to call me to serve as your pastor. I thank God for the opportunity to serve in this amazing community of believers! You all have provided me with so much joy, care, and nourishment during my first (almost) year and I am so grateful for everything you do.

This past fall, we looked at what disciples do. As disciples of Christ, we are called to many things, chief among them being the care of others. As Katie and I were going through not having a fully functioning Kitchen, you provided us with home cooked meals. When the Food Pantry needed items to give away, you stepped up to provide many non-perishable food items. When we have asked for help at the church, you stepped up and provided the assistance that was needed. For all these things and for all those I didn't mention, I, and many others, are eternally grateful.

As disciples of Christ, it is important that we look back at and celebrate what we have done together. Since I started at Kindred Lutheran, we have gotten to celebrate the Baptisms of 7 young Christians. This fall we celebrated as 2 young adults affirmed their Baptisms. We also welcomed 18 new members into our community of faith and the mission we share. Then this winter we celebrated the wedding of one of the daughters of this congregation. We also have amazing numbers of children and youth involved in programming, including around 50 for Vacation Bible School, around 80 in Sunday School, and 28 youth in confirmation. On top of that we had 15 people join for Bible Study during Advent. All these things are well worth celebrating.

But, as disciples of Christ, we can't just get comfortable with where we have been. We need to look forward to what is to come and the work that we will be doing. So, this year, I wanted to set some goals for this community of faith:

- 1. To see more people worshipping God. This year we averaged 89 people in worship every Sunday. This is an increase from last year. My goal for this year is that we break into triple digits for our in-person attendance. So, I encourage you to join us for worship, invite your friends and neighbors, and reach out to those you haven't seen in a while. It is good for all of us to gather together for many reasons. As it says in Hebrews: "And let us consider each other carefully for the purpose of sparking love and good deeds. Don't stop meeting together with other believers, which some people have gotten into the habit of doing. Instead, encourage each other, especially as you see the day drawing near." (Hebrews 10:24-25)
- 2. To see our children's and youth programming grow and thrive. We had great numbers of students in our programming this year, but there are certainly opportunities for more to join us. I would love to see Vacation Bible School charge past 50 kids in attendance. I would love to see Sunday School have more consistent attendance. I would love to see our youth encouraged to get involved with the activities that Trish is planning. As Christians, we are called to encourage and support children in worship and throughout their lives, because it is what Jesus did. "Jesus said, "Let the little children come to me, and do not stop them; for it is too such as these that the kingdom of heaven belongs." (Matthew 19:14)

3. To see more people getting involved in the life of the church. There are many things we want to do as a church, but none of them can happen without you. This is maybe the most important thing because the church cannot function properly if we do not have people getting involved. My hope is that as we go throughout this year, we have increased engagement in Sunday Morning volunteers, Bible Study, and other engagement opportunities. If you have ideas for opportunities, we can offer at KLC, please let me know. "Little children, let us love, not in word or speech, but in truth and action." (1 John 3:18)

I know that we will continue to grow and shape our faith together as Kindred Lutheran Church. My hope is that you are as excited as I am for what is to come!

YOUTH DIRECTOR

CONFIRMATION

The current 2022-2023 confirmation class has 28 students in confirmation classes, which includes grades 7 and grades 8. We have welcomed 2 of those students from Walcott. Confirmation is held Wednesday evenings from 4:15pm-5:15pm. Confirmation starts the month of September and runs until May. The Kindred Public Schools calendar is utilized when determining Wednesday that confirmation will not be held. Confirmation continues to utilize a Pastor and Youth Director team.

Confirmation is utilizing "Echo the Story" provided by Sparkhouse Confirmation. Using Sparkhouse materials aligns with the Kindred Kids curriculum. Confirmation supports are used to help guide students when reading bible passages and decoding scripture readings. Students partake in a variety of activities to deepen content, such as teaching each other, making the content visual, reflect and discuss, and so on.

Confirmation students are expected to participate in Kindred Lutheran Church in a variety of ways. Students sign up for selected Sundays to aid in worship duties. Flexibility upon how students meet their time involved allows for Sunday School help or joining choir. Students are also expected to take sermon notes.

During the time of transition from Jan 2022-Mar 2022, the Youth Director ran confirmation with parent support. Various teaching materials were used as Sparkhouse content was not available at that time.

Teachers in 2022 were Pastor Kyle Giermann and Trish Miller.

AFFIRMATION OF BAPTISM - 9th Grade Confirmation

Confirmation for 9th grade students met starting in September 2021 through October 2021 for which Confirmation Sunday was celebrated. There was a total of 2 students who were confirmed. Meetings for 9th grade confirmation were held at 9am on Sundays.

During the 2 months of meetings, students took part in making a Faith Project and writing a faith statement. The Faith Project could include several aspects compiled to match the youth's life theme. Such as: baptism pictures, favorite bible stories, who you admire from the bible, influential people from your faith journey, faith statement, and how you live your faith outside of the church.

A confirmation supper, which was put together by half of the parents of the previous year confirmation group, is held the night before confirmation. A short service led by Pastor Giermann and Trish Miller prepared the confirmation students for the next day. Faith projects were displayed during the supper for both families to see.

Confirmation Sunday service was held at 10am. Both confirmands were able to attend. Faith projects were also displayed for the congregation to look at.

YOUTH GROUP

Youth group is for grades 9-12th. Youth group time was offered Wednesday evening from 5:30ish-7:30. Supper at some meetings was provided. Youth attendance is low. Contact with all youth is still attempted. Many times, the Youth Director connects with youth at community events.

Activities:

- SR. Quilts: 11 Seniors received a SR. quilt from KLC quilters.
- End of the School Year Supper: Youth attended a special dinner after service in which Pastor Giermann and Trish Miller treated kids to Johnny Carino's.
- Camp Castaway: September Camp was set for ELCA youth and KLC combined efforts with Norman-Davenport Youth and congregation. The collaboration allowed for bussing transportation, chaperone coverage, and youth to share faith with friends. KLC had 16 youth grades 6-10 attend.
- Movie Night: Rally Sunday on a Saturday night featured an outdoor movie.
 Screen and projector were used courtesy of the Davenport Park Board. Youth gathered to watch Remember the Titans outside on a beautiful September evening.

KINDRED KIDS

ATTENDANCE

Kindred Kids were back to in-person only Sunday School for the full year after a portion of 2021 was offered virtually. Masks were not required but hand sanitizer was offered in all classrooms.

83 students were registered for Sunday School in the fall of 2022 which started on September 11th, 2022, with Rally Sunday hosted after the church service that day. September 18th our normal classroom Sunday school began from 9:00 AM to 9:45 AM. Class sizes ranged from 8 to 14.

BUDGET

The allotted \$4,000 budget has covered the Kindred Kids needs for the 2022 Sunday School year. I have the budget broken down between curriculum, room décor, supplies, Christmas program, Rally Sunday, Special Events, Teacher Gifts and the May program. I do believe we will have a surplus at the end of this year, but we are looking at adding to Rally Sunday, possibly doing some accent wall painting in the rooms and special events categories next year.

COMMUNION

First Communion Class was held on April 10th during the Sunday School from 9:00 to 9:45 for the 5th grade class.

CURRICULUM

Sparkhouse Digital was continued for the second year as the curriculum for Sunday School which follows a lectionary-based curriculum so that it would fall into place with the pastors Sermons. The curriculum is online based so binders were printed and made for all teachers. Sparkhouse leaflets are an extra charge, but we chose to purchase them this year to help teachers with additional activities. No additional bibles were ordered this year.

EVENTS

Palm branches were ordered for Palm Sunday, so we ordered small ones for Pre-K through 3rd grade and large ones for 4th through 6th grade. Additional palms were ordered for the congregation as well.

The Kindred Kids program and last day of Sunday School was on May 15th. The students lead the worship service, recited their memory pieces and shared special music. Fellowship provided food after worship, and we celebrated with cupcakes and sunglasses for the children.

Rally Sunday was held on September 11th, 2022, as a family event with inflatable bounce houses, yard games and a balloon twisting artist which was a big hit. Candy bags were left in the children's classrooms for them to find so they knew where to go the following week. Fellowship committee hosted a potluck on that day as well. 3rd grade bible class was held on October 2nd as a 1 day, 1 hour session with Pastor Kyle with child plus 1 parent in attendance.

The Christmas Program was held on December 18th, 2022, put on by our music teachers Terrand Fiesel and Erin Kub. The program was held in KLC during the normal church service hour.

MUSIC

Sunday school students participated in music for 15 minutes each week. Erin Kub lead Pre-K through 2nd grade from 9:05 to 9:20 and Terrand Fiesel lead the 3rd-6th grades from 9:30 to 9:45. Each group sings one Sunday each month during the regular church service.

Kindred Area Food Pantry, Great Plains Food Bank, and Kindred Elementary and High Schools partner together for the **Kindred Area School Backpack Program**. The Backpack Program provides a bag of kid-friendly food to students each Friday for each weekend during the school year. The cost per weekend per student is around \$5. Additional bags of food are provided to students on long weekends when there are days off from school.

In the school year 2021-2022, a little over 300 bags of food were distributed. In the spring of 2022, high school students were added to the program. A total of 3,623 bags of food have been distributed since the beginning of 2015.
