Rather, the Holy Spirit transforms us so we become more like Jesus for others. We grow in grace – grow in seeing how totally dependent we are upon God's graciousness to us.

Following Jesus is a journey, a lifelong process of faith formation that we describe simply as: **Gathered to Grow...Sent to Serve!** This is our vision. And everything that we do at Kindred Lutheran is focused on this faith formation process. It is our way of helping one another become the disciple Jesus is calling us to be. Discipleship is what **we** do. Faith formation is what **God** does.



- In 2021, it is suspected attendance may have remained low due to circumstances related to the ongoing COVID-19 global pandemic and the absence of a permanently called Pastor.

#### A note on digital metrics:

In March of 2020, KLC began to live stream our Sunday morning services using the Facebook Live platform. This platform was selected as the most cost-effective and user-friendly method available to KLC at the time. The program has been a very useful tool in the life of our church. Regarding the reporting of attendance at KLC, a major downfall of the program is the inability to accurately measure the number of viewers. The platform was not built for the use of church services and therefore analytics are lacking for those measurements we are most interested in.

The simplest metric is 'Views' per video. However, on Facebook, every time a device scrolls past a video and it plays for 3 seconds, *unclicked or clicked*, it is counted as a view. On any given KLC video, you'll see 150-250 "views" which is extremely misleading and therefore will not be used in this report.

One metric we can use is called 'Unique Video 60-Second Views'. This will tell us how many unique devices *clicked* on the video and watched for a minimum of 60-seconds.

One other attendance metric available to us is called '**Complete Views**'. This counts the number of times viewers watched at least 97% of the video. However, this too can be misleading. For example, if a viewer leaves the video after the Sending Song but the live feed keeps going for another 15 minutes this would not be counted as a "complete view".

To help us build a picture of attendance online, this report will illustrate both 'Unique Video 60-Second Views' and 'Complete Views'.

The sale was in the parking lot on a hot, windy day. (Thank you, Joan Halland!) A volunteer was part of a car wash at NDSU and donated the money to the Auxiliary.

### **SPECIAL OFFERINGS**

Thanks to everyone for your generous donations to the following special offerings!

- 1. <u>Love offering (local)</u>: A total of \$440 was collected at the February 17<sup>th</sup> worship service and was donated to the Kindred Food Pantry.

### YOUTH DIRECTOR

#### CONFIRMATION

There are currently 16 students in confirmation classes, which includes grades 7 and grades 8. We have welcomed 2 of those students from Walcott. Confirmation is held Wednesday evenings from 4pm-5:30pm. Confirmation starts the month of September and runs until May.

The Kindred Public Schools calendar is utilized when determining Wednesday that confirmation will not be held. Confirmation continues to utilize a Pastor and Youth Director team. During time of transition and pulpit supply, confirmation has been ran by Youth Director with parent support.

Confirmation utilizes Sunday scripture, ELCA resources, and seasonally themed content. Confirmation supports are used to help guide students when reading bible passages and decoding scripture readings. Students partake in a variety of activities to deepen content, such as teaching each other, making the content visual, reflect and discuss, and so on.

Confirmation students are expected to participate in Kindred Lutheran Church in a variety of ways. Students sign up for selected committees such as worship duties or Sunday School teaching. Students are also expected to take sermon notes which copies are provided to all parents as well as clipboard and copies in the church.

Teachers in 2021 were Pastor Corey Lange, Pastor Michael Buller, and Trish Miller.

#### **AFFIRMATION OF BAPTISM - 9th Grade Confirmation**

Confirmation for 9th grade students met starting in September 2021 through October 2021 for which Confirmation Sunday was celebrated. There was a total of 7 students who were confirmed. Meetings for 9th grade confirmation were held at 9am on Sundays.

During the 2 months of meetings, students took part in making a Faith Fold and writing a faith statement. The Faith Fold included several aspects compiled to match the youth's life theme. Such as: baptism pictures, favorite bible stories, who you admire from the bible, influential people from your faith journey, faith statement, and how you live your faith outside of the church. Faith Folds were made on a large cardboard tri-fold and presented to the church during confirmation supper. All faith statements were presented during a worship service by the youth reading to the congregation.

A confirmation supper, which is put together by parents of the previous year confirmation group, is held the night before confirmation. During the supper, a special speaker, Joan Halland, gave a small account of faith and hope for the confirmation students moving forward. A short service led by Pastor Buller and Trish Miller prepared the confirmation students for the next day. Faith Folds were set up in Fellowship Hall for all to look at. Certificates were handed out to families.

Confirmation Sunday service was held at 10am. All 7 confirmation students were able to attend.

#### YOUTH GROUP

Youth group is for grades 9-12th. Youth group time frame has varied for the year 2021. Meetings have happened for the most part on Sundays at 1pm. Members have increased over the year, but not all gather at each meeting. Contact with all youth is still attempted. Many times, the Youth Director connects with youth at community events.

Youth Group room is now located next to Youth Director office. The room is currently being used by Sunday School on Sunday monrings. Many relaxed seating options in the room as well as youth décor. Youth use this room during youth group and have been able to fit the needs of both groups.

KLC Youth have been named "Christians in Action" and the mission statement is to "Be the Light". Cre8tive TZs in Enderlin worked with Youth Director to print shirts which were given to youth and sold to congregation members. Other swag such as pens, stickers, and water bottle decals were purchased or donated.

#### Activities:

A group of 10 youth attended a tubing day at Thrill Hills, Fort Ransom. The youth also put together "He is Risen" magnets for Easter food baskets for the community. Rally Sunday 2021 included a Gyrosphere activity used in promotion of KLC Youth. After the Sunday School Christmas Program 2021, the youth provided hot chocolate and together as youth and congregation they put together Christmas food baskets with bag tags. Youth participated in "Worship through Service" Sunday which all the youth 7-12 grade that were present helped with cleaning up Lucky Ducky's daycare in Kindred. Camp Castaway was cancelled once again for 2021.

Youth Group has received the Burger Stand fundraiser, which Kindred Days 2020 was the first year. Four youth were able to participate, and several youth parents, and council members were able to help. Funds from the Burger Stand were designated to be used for the National Youth Gathering in Minneapolis, MN. (As of Feb 2021, Youth Gathering is cancelled)

- Continue to utilize Burger Stand for fundraising, have more youth help
- Change Youth Group meetings to Wed from 5:45pm-7pm with supper and a set rotating calendar of activities
- Attend Youth Gathering (cancelled as Feb 2021)
- Attend a bible camp
- Continue to engage in community service

### Youth Spending:

Spending focused on youth supplies for both confirmation classes and Youth Group. Items such as shirts, a Cricut (crafting) machine, games, sports equipment, and activity supplies were purchased. Confirmation was able to return Sunday School supplies.

### KINDRED KIDS

#### **ATTENDANCE**

Virtual and in-person Sunday school were offered from January-March. Virtual lessons were posted on the Kindred Kids Facebook page every Sunday and focused on Jesus's parables and miracles. March 28<sup>th</sup>, the last virtual lesson was posted. In-person Sunday school followed the curriculum in the classroom. Masks were required in the classroom and music performances were videoed and shared with the congregation during worship.

82 students were registered for Sunday School in the fall of 2021 which started on September 12<sup>th</sup>, 2021 from 9:00 AM to 9:45 AM. Class sizes ranged from 4 to 13.

### **BUDGET**

The allotted \$4,000 budget has covered the Kindred Kids needs for the 2021 Sunday School year. I have the budget broken down between VBS, curriculum, room décor, supplies, Christmas program, Rally Sunday, November Giving Drive, and the May program. I do believe we will have a surplus at the end of this year but I know VBS and Rally Sunday categories will

be looking at increases for 2022 that will bring us back up. VBS is working on transitioning between a joint VBS with Norman Lutheran Church and our own VBS.

### **COMMUNION**

On March 21st, Pastor Michael held a first communion class for the 5th and 6th graders. The 6th graders did not receive first communion last year due to Covid. On March 28th, they made bread and on Maundy Thursday, they sat by tables at the front of the sanctuary and had a traditional Passover meal during the service.

### **CURRICULUM**

Sparkhouse Digital was chosen as the new curriculum starting in the fall of 2021 which follows a lectionary-based curriculum so that it would fall into place with the Pastor's sermons. The curriculum is online based so binders were printed and made for all teachers. Leaflets were an extra charge so not utilized but new story-based bibles were ordered to go along with the curriculum for each classroom.

#### **EVENTS**

The Kindred Kids program and last day of Sunday School was on May 16th. The students led the worship service, recited their memory pieces and shared special music. Hotdogs and chips were served after worship, and we celebrated with bouncy houses on the lawn.

Rally Sunday was held on September 12<sup>th</sup>, 2021 as a family event with inflatable bounce houses, a pinata and yard games in the lawn while the fellowship committee provided a meal.

The Christmas Program was held on December 12<sup>th</sup>, 2021 put on by our music teachers Tarrand and Erin. The program was held during the regularly scheduled Sunday morning worship service at KLC. The youth group provided hot cocoa afterward.

### **MUSIC**

On April 25th, Kindred Kids had their first in-person performance during the worship service in over a year due to COVID. In the fall of 2021, Sunday school students participated in music for 15 minutes. Erin Kub led Pre-K through 2<sup>nd</sup> grade from 9:05 to 9:20 and Tarrand Fiesel lead the 3<sup>rd</sup>-6<sup>th</sup> grades from 9:25 to 9:40. Each group sings one Sunday each month during the regular church service.

#### **OFFERING**

No offering was taken a weekly basis, but we did focus on our Christmas Donation to the Jeremiah Program where we provided 34 pairs of pajamas and 20 self-care items for the mothers living in the building.

#### **SPECIAL GIFTS**

5 Preschoolers received bibles donated by Leah Lundquist in memory of Luke Zeitlow and 7 3<sup>rd</sup> graders received bibles donated by Jean Lahren Washa in memory of Jo & Marcella Lahren. VBS

A separate report was done specifically for VBS from summer of 2021 with committee members Erin Kub, Tarrand Fiesel and Dona Schock. Erin and Tarrand did offer to head that up again in the summer of 2022.

#### KINDRED KIDS COMMITTEE MEMBERS

Stephanie Swanson, Tarrand Fiesel and Erin Kub stepped down after many years on the Parish Ed/Kindred Kids Committee.

New members for 2021 are Kelly Engstrom and Jessica Althoff but are still looking to add 1 or 2 members!

### **2021 VBS REPORT**

Kindred Community VBS was held at Kindred Lutheran Church <u>July 26-29<sup>th</sup> from 5:45-8:00pm</u>. The Norman-Davenport Lutheran Parish organized and held their own VBS this year on August 1<sup>st</sup>. It was mutually agreed upon earlier this spring by the KLC and N-D VBS Committees that we would hold our own VBS this year. We will discuss future plans of possible collaboration at a later date.

<u>Kids attended</u>: 31 (9 preschool/kindergarten & 22 1<sup>st</sup>-5<sup>th</sup> graders)

Adult volunteers: 12 Youth volunteers: 5

Curriculum: 2019 Group VBS "ROAR"

- This is a 5-day curriculum, so we cut out Day 4 to fit in our 4-day VBS
- Students rotated between 4 stations and all attended the opening music, snack and closing music

Sign-up Genius was used for parents to register their child as well as donate snacks and some materials. Parents were sent and filled out a waiver on the KLC website for their child prior to the first day of VBS. All snacks were donated by families. Parents were sent updates and reminders by email. The updates and reminders were also posted on the Kindred Kids Facebook page.

The VBS Committee met 3 times to plan and organize the event. All committee members volunteered as leaders during the week as well as their older children. Some of the materials were purchased or created by the committee members and donated to VBS. We anticipated the cost to be around \$500 dollars, but because of the donations, it was much closer to the \$300 budget.

### **CALL COMMITTEE**

The Call Committee was formed in late 2020 with the intent to call a Term Pastor after Pastor Andrew Schlecht was called to serve in Arizona. The Synod helped guide us to that option because of the lack of interim pastors available in the area. The Synod suggested a shorter term/interim pastor after a long-term pastor as a break between the two - a time for healing and grieving the loss of the long-term pastor, and also a time to discern what you are looking for in the next pastor. After prayerfully considering 4 candidates, we recommended and Congregation voted to call Pastor Michael Buller to serve a 15-month term call with KLC in January 2021. He started with KLC in March of 2021. Pastor Michael received another call and left KLC in November 2021.

Pastor Michael was a wonderful resource to the Call Committee in helping form a survey to the Congregation to guide our Ministry Site Profile (MSP). The MSP is basically a resume of what KLC is looking for in our next pastor. This document is a 12 page document full of information on the past, present and future of KLC. We worked on the MSP from January to September 2021. I want to take a moment and thank the Call Committee members for their hard work on this project.

The Call Committee submitted the final MSP to the Synod office September 23, 2021. Since then, we have interviewed 7 candidates and of those 7 we've provided 3 second interviews. We have one candidate in mind right now and we are waiting and praying for God's guidance on a couple of things before we continue. We know the congregation is excited to see who the next pastor at KLC will be - we are too! Please keep the Call Committee and the future pastor of KLC in your prayers.

Kindred Area Food Pantry, Great Plains Food Bank, and Kindred Elementary School partner together for the **Kindred Area School Backpack Program**. The Backpack Program provides a bag of kid-friendly food to students each Friday for each weekend during the school year. The cost per weekend per student is \$5. Additional food is provided to students on long weekends when there are days off from school.

In the school year 2020-2021, a little over 400 bags of food were distributed. A total of 3,299 bags of food have been distributed since the beginning of the program 2014-2015.
